

INFORMATION REGARDING EXTRA SPECIAL BENEFIT FOR SINGLE PARENTS

Support benefit will be given to single parents!

※Single parents will be given support benefit as a measure against New type corona virus infection. This include those “Single parents” who have not yet applied for 児童扶養手当 or child support benefit but since this will be difficult to specify, a campaign has been conducted to inform everyone. (Those who had already applied for child support benefit in Yokkaichi will be sent with special information). Please read the flowchart on the back page to know if you are qualified to be a recipient of this support relief. (①～④)

Qualified recipients

○National benefit

- 【Recipient①】 Those who received child support benefit for the month of June 2020.
- 【Recipient②】 Those who will receive National pension that is why child support benefit for the month of June 2020 will be stopped.
 - ※Those who think that the whole or part of the amount child support benefit for the month of June 2020 will be stopped if they will apply for child support benefit are also included.
- 【Recipient③】 Those family budget suddenly changed because their income declined due to new type corona virus infection and just the same level to those receiving child support benefit.

Basic benefit

1 Household 5万円, from the 2nd child, 3万円 for each child



Additional benefit

1 Household 5万円 (※)

※Recipient ①, ② above can receive additional benefit if their household budget has changed because of decrease in income due to the effect of new type corona virus infection.

○City benefit (※Those mentioned above who already received National benefit are not included.)

- 【Recipient④】 Single parents who do not belong to Recipient ①～③ above
Those who are under divorce consultation, DV evacuees may receive City benefit if they meet some conditions.

Benefits application procedure

- Place of Application : Sogokaikan 総合会館 1 F Kyutukin Counter 給付金担当窓口 (Venue might change from October)
- Date of Application : 2020 August 3 (Mon)～2021 Feb. 26 (Fri)
- Documents to be submitted
 - 【Recipient①】
 - No need to apply for basic benefit. For additional benefit, please submit the application form enclosed with the separate information.
 - 【Recipient②、③、④】 Application form is available at the Counter of place of application (You can also download it from City Homepage) .
 - Application form (For Recipient② separate application is needed to receive additional benefit.
 - Copy of personal documents that would confirm the identity of the applicant
 - ※Driver's Licence, Health Insurance, My Number Card, Pension book, Long-term insurance card, Passport etc.)
 - Copy of bank account to be used in receiving the benefit
 - (※For those who already applied for Child support benefit, only the account you use for bank transfer of child support benefit is allowed.)
 - Documents that will prove that support is needed (Not needed if already receiving child support benefit)
 - (Recipient② at ③)
 - KOSEKITOHON 戸籍謄本 (Family register) or SHOHON 抄本 (extract copy of family register) of the applicant and the qualified child, NENKIN SHOSHO 年金証書 (Pension certificate) related to SHOGAI NENKIN 障害年金 (disability pension) of father or mother with disability. (Only those in 1st level of disability class)
 - (Recipient④)
 - KOSEKITOHON 戸籍謄本 (Family register) or SHOHON 抄本 (extract copy of family register) of the applicant and the qualified child, NENKIN SHOSHO 年金証書 (Pension certificate) related to SHOGAI NENKIN 障害年金 (disability pension) of father or mother with disability (Only those in 1st level of disability class), other than these, documents that will prove that is under divorce consultation or DV evacuees.)
 - Petition for expected small revenue (income) (Not needed for Recipient ④)
 - (Document enclosed for Recipient ②)
 - Document that will show the income of the applicant and supporter of the household (Parents, grandparents, siblings living together) such as KAZEI SHOMEISHO H31課税証明書 (2019 Tax certificate) (H30 年中 whole year 2018) , Bank transfer notice of pension etc.
 - (Document enclosed for Recipient③)
 - Document that will show the income of the applicant and supporter of the household (Parents, grandparents, siblings living together) such as (1 month) payslip from 2020 February, Bank transfer notice of pension etc.
- Period of issuance of benefits
 - 【Basic benefit for Recipient①】 Mid August thru bank transfer
 - 【Other than mentioned above】 Bank transfer after screening (from mid-September～bank transfer will begin)

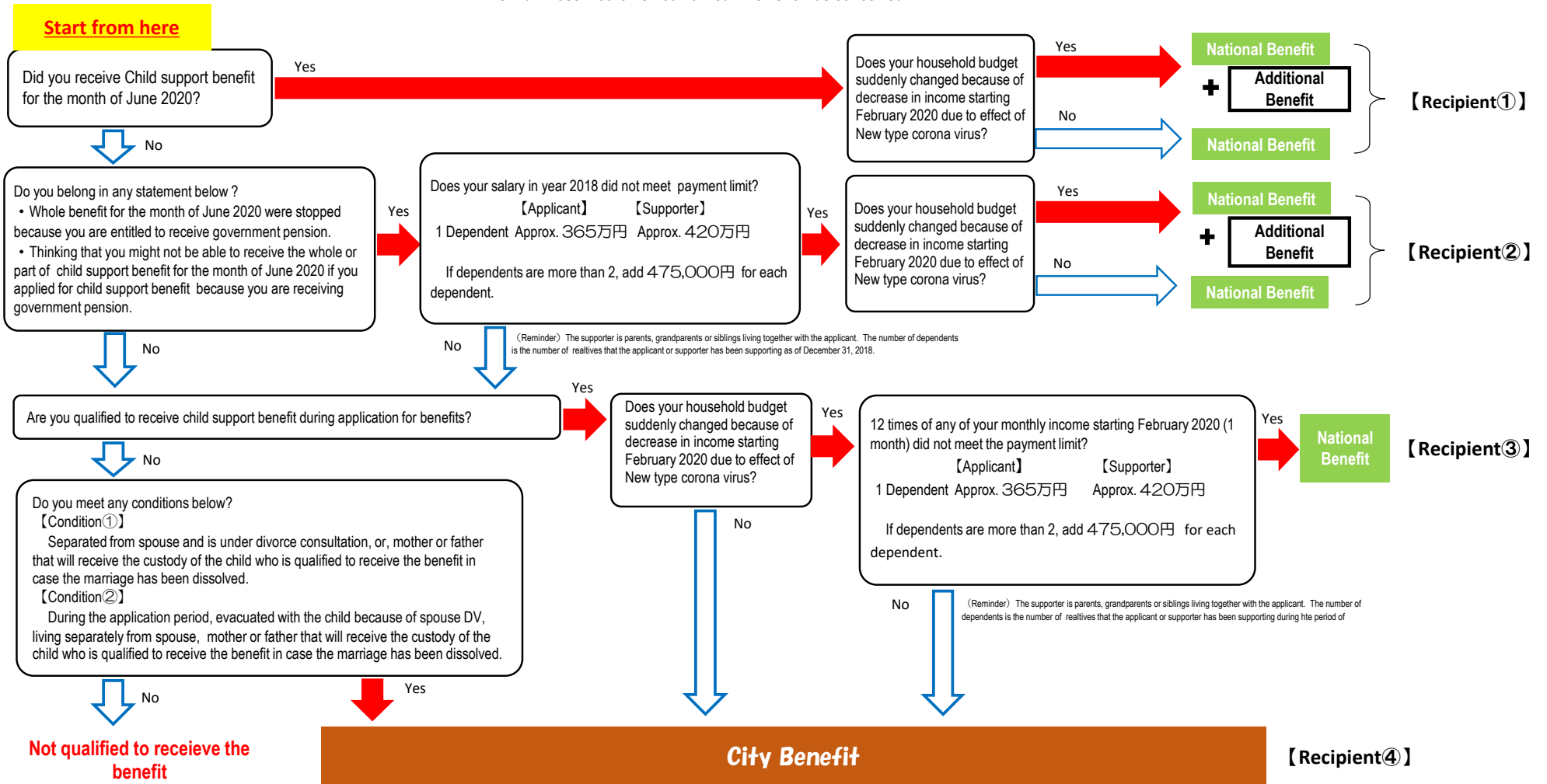

※「Qualified for child support benefit」 are those who are qualified to receive benefits because the child is under his/her custody based on Child Support Benefit Law Article 4.

(Primary conditions)

- Child whose parents' marriage has been dissolved. (Including common-law marriage)
- Child whose father or mother is dead
- Child whose father or mother has disability
- Child whose father or mother is under life protection because of DV
- Child whose mother is not married when she was conceived
